PROCEDURE

1. Hold pre-job safety meeting. Comply with all NMOCD, BLM, and COP safety and environmental regulations. **Notify BLM and NMOCD 24 hours prior to MIT to obtain witnesses.**
2. Check casing, tubing, and bradenhead pressures and record them in WellView. If there is pressure on the BH, contact Wells Engineer.
3. Remove existing piping on casing valve. RU blow lines from casing valves and begin blowing down casing pressure.
4. Load casing with 2 % KCl water & corrosion inhibitor, as necessary. Perform MIT between the 2-3/8" tubing and 7" casing above the packer at 3060' to 560 psig for 30 minutes on a 2 hour chart with 1000 lb. spring. If the test passes, SI the well. RD pump truck and MOL. If the test fails, contact the Rig Superintendent and Wells Engineer.
