Encana Oil & Gas (USA) Inc. (Encana) recently finalized the formation of a 13,137 acre Federal exploratory unit named the Bettonnie Tsosie Wash Unit. The hearing for this unit occurred on June 25, 2015 at the Oil Conservation Division in Santa Fe, in which Encana requested that the undivided unit be formed that would also encompass its own unique oil pool designation. The Hutton Canyon Unit M11-2308 03H well will now be part of the Bettonnie Tsosie Wash Unit. Therefore, we are submitting this sundry to change the name from Hutton Canyon Unit M11-2308 03H to Bettonnie Tsosie Unit 109H.

Please note, the Application for Permit to Drill for this location was never approved by the New Mexico Oil Conservation Division because the agency was waiting on unit approval of the Hutton Canyon Unit. The Hutton Canyon Unit is now a part of the Bettonnie Tsosie Wash Unit, which has been approved.




