Pumped a preflush of 20 bbls FW w/dye in last 10 bbls. Pumped lead - 450 sx (1175 cf - 209.26 bbl slurry) Class "G" w/3% extender, 0.2% antifoamer, 0.25#/sx Cello-flake. Tail - 100 sx (127 cf - 22.61 bbl slurry) Class G, 50/50 POZ, 0.253/sx Cello-flake, 5#/sx Gilsonite, 2% Bentonite, 0.2% Antifoamer, 2% CaCl2. Displaced w/125 bbls water. Plug down @ 2215 hrs 6/6/03. Circ. 30 bbls good cement to surface. ND BOP, set slips and cut off casing. RD & released rig 0600 hrs 6/7/03. Will show casing PT on next report.
