

The Ludwick LS 003 well API 30-045-09120 was plugged and abandoned on 2/13/2009. As of 9/30/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 1, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.
