


13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. The Gallegos Canyon Unit 196 well API 30-045-11569 was plugged and abandoned on 4/26/2007. As of 11/14/2016 BP has completed reclamation work to include equipment removal, re-contouring, and seeding of location. On December 8, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.
