


If the operation results in a multiple completion or recompletion in a new interval, a Form 3160-4 must be filed once testing has been completed. Final Abandonment Notices must be filed only after all requirements, including reclamation, have been completed and the operator has determined that the site is ready for final inspection.

The WD Heath A 014 well API 30-045-23902 was plugged and abandoned on 5/15/1998. As of 9/26/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 1, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.
