The Day 005 E well API 30-045-25472 was plugged and abandoned on 11/14/2002. As of 8/16/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 1, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation. During the site visit it was noted that an Enterprise Riser remains on location and needs to be removed. On 12/7/2016 Sarah Clelland with Enterprise was contacted via email that this riser is needing to be removed from location and that reclamation work has been completed as of 8/6/2016.
