- 12/09/2016-** Set CR at 1664' **Plug #1** spot 36 sxs (42.48 cf) Class B cement from 1664' to 1190' to cover the Pictured Cliff interval and Fruitland Coal top. **Plug #2** with 56 sxs (66.08 cf) Class B cement from 646' to surface circulate good cement out 4-1/2" casing to cover the Ojo Alamo top and casing shoe.
- 12/12/2016-** Cut off WH. Found TOC at 6' down in 4-1/2" casing and down 22' in annulus. **Plug #3** with 12 sxs Class B cement top off casings and install P&A Marker, R/D and MOL.
