The Gallegos Canyon Unit 400 well API 30-045-26288 was plugged and abandoned on 5/19/2009. As of 8/2/2016 BP has completed reclamation work to include equipment removal, re-contouring, and seeding of location. On December 20, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation.
