WPX Energy requests authorization to flare the **MC 1 COM #282H** if a potential cross flow event may occur as a result of a nearby Frac activity on **W Lybrook 701H/702H**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **3/23/17 for 30 days**, given approval.
