2/23/17 Set RBP above the FTC perfs at 1400' KB. Loaded the well with produced water. Set a packer at 1386' KB. Tested the RBP and pkr to 900 psi - held OK. Pressure tested the annulus to 1,000 psi - held OK. No casing leak. Reset the RBP between the PC and FTC perfs at 1550' KB. Treated the FTC with 25 gal of nanofluid and 306 gal of acetic acid mixture. Re-ran the tubing and pump. Returned the well to production 3/28/17.  
Plan to produce the FTC separately for 30 to 60 days.
