


WPX Energy requests a continued authorization to flare the **WARNER-CALDWELL 1A** if a potential cross flow event may occur as a result of a nearby Frac activity on **W Lybrook 704H/743H/744H** still occurring. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, WPX requests an additional 30 days from our current expiration date of 4/12/17, given approval.

A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.
