Cement with 165 sks, 227.7 cu ft Halliburton Halcem cement blend (13.5#/gal, 1.38 cu ft/sk, 5.85 gal/sk mix water, Class G with 50 percent poz, 1% bwoc bentonite, 5#/sk Kol-seal, 0.125#/sk Pol-E-Flake, 0.1% bwoc CFR3 & 2% CaCl2). Total cement volume 227.7 cu ft, 40.5 bbls. Displace w/15.5 bbls water. Circulated 15 bbls cement to surface. D&D Drilling Rig 1 released May 8, 2017. Pressure test to be reported on completion sundry. ✓
