
EMERGENCY FLARE EXTENSION

E. WPX Energy requests authorization to flare the CHACO 2308-16I #147H if a potential cross flow event may occur as a result of a nearby Frac activity on Rodeo Unit #500H/501H. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as 7/25/17 for 30 days, given approval.

A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.


