XTO Energy proposes to change out an existing pumping unit that causes frequent holes in the tubing due to the reciprocating rods having to pump >100 BWPD. We plan to convert to an ESPCP (electric submersible progressive cavity pump) which will eliminate holes in tubing and remove water more effectively, thus increasing the gas production on the lease(s) and reducing workover costs. The conversion will require electric power to be installed to the location.

The Irish 1 well is on Navajo Allotment BIA NO-G-0503-1724, in NW/4 Sec. 22, T25N, R10W, San Juan County, NM. This location will require an approximately 500' underground electric power line from Jemez Electric to the location. XTO has existing access road and gas/water pipeline R-O-W's in place. We would like to utilize the same corridor and will avoid additional ground disturbance.
