Encana Oil & Gas (USA) Inc. (Encana) recently finalized the formation of a 14,706.50 acre Federal exploratory unit named the Good Times Unit. The Good Times Unit hearing occurred on October 1, 2015 at the New Mexico Oil Conservation Division in Santa Fe, in which, Encana requested an undivided unit be formed that would also encompass its own unique oil pool designation. The unit was approved by the BLM on May 5, 2017 with an effective date of March 1, 2014.

The Escrito L17-2409 02H well, which was approved by the BLM on November 18, 2013, will now be a part of the Good Times Unit. Encana is submitting this sundry to change the well name from the Escrito L17-2409 02H to the Good Times Unit 302H.






