Pressure tested well to 3000 psi for 30 minutes; held ok. Ran GR-CCL-CNL logs. Perforated (7/7/17) from 548'-555', 564'-568', 607'-618' (total 22 feet, 88 holes). Fracture treated well on 8/22/17 with 600 gallons 15% HCl, 61,000 gallons crosslinked foam and 109,500# sand. On 8/24/17 ran 19 jts 2-3/8" 4.7#, J-55 tubing, landed @ 653', SN @ 617'.
