Received verbal approval from Charlie Perrin, OCD, to alter MV P&A plan to only spot 100' cement plug above cement retainer. Spot cement plug from 3510' - 3610'. TOH. MV is now permanently abandoned.
03/24/06 Pressure test plug to 500#.
