Elm Ridge Exploration CO LLC reached a TD of 1455' on 3-27-06. Ran 5 1/2" 15.5# J-55 casing to 1436'. Pumped 155 sks of STD cement. Tailed in w/ 110 sks of STD cement w/ 2% CSCL2. Circulated 23 bbls excess cement to surface. Pressure tested well to 1500 PSI.

- The APD was approved for a 4 1/2" production casing string. This office has no record, written or verbal, approving a casing size change for the production string.
