Cmt'd w/ 110 sxs Cl "B" + add @ 12.5 ppg followed by 70 sxs Cl "B" w/ add @ 15.6 ppg. Circ 22 sxs to surface. Plug down @ 10:40 hrs 02/17/06. Test csg to 1000# for 30 mins ok. Ran CBL 03/03/06.

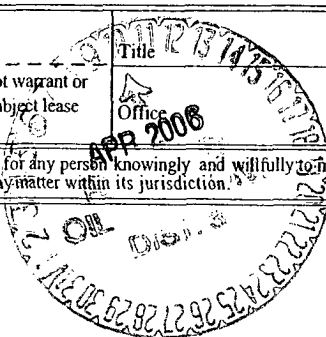
