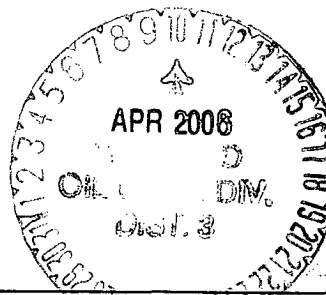

Cement first stage with 55 sks 65/35 Class B poz, 6% gel, 10#/sk gilsonite, 1/2#/sk flocele, 2% CaCl2 tailed by 50 sks Class B, 5#/sk gilsonite, 1/4#/sk flocele (170 cu.ft.). Plug down @ 2:45 pm on 03/14/06. Circulate 3 bbls cement to surface. Circulate between stages. Cement second stage with 535 sks 65/35 Class B poz, 6% gel, 10#/sk gilsonite, 1/2#/sk flocele, 2% CaCl2 tailed by 50 Class B, 5#/sk gilsonite, 1/4#/sk flocele (1111 cu.ft.). Plug down @ 8:15 pm on 03/14/06. Did not circulate cement to surface. WOC. NU BOP. Test casing & BOP to 1200 psi - ok.
