On September 25, 2017 the Farmington Field Office, Bureau of Land Management conducted a field inspection on the Richardson #6, 1190' FSL & 2400' FWL, Section 10, T27N. R13W, lease number SF – 077972 to evaluate the success of the final reclamation for this well site. According to our records this well was plugged on 8/7/1996. The results of our inspection are as follows:

- 1) Junk and facilities on site
- 2) No API number on P&A marker
- 3) Location not shaped and blended to local topography
- 4) Stained soil on site
- 5) Non native gravel on site
