

13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recomplete horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. BP respectfully requests an additional 60 days from the current 10/17/2017 deadline to run tubing in the subject well. We need to continue gathering well pressure vs production data at higher rates than what is possible through tubing (i.e. >13 mmscfd) to properly evaluate the reservoir performance of the well using analytical models. Our current projection is that the well production will decline to this rate by 12/20/2017 without tubing. This additional information will help future well, facility and gathering system designs to maximize recovery from the Mancos formation in NEBU.
