This well has 7" casing in it. We would like to retain this wellbore to use as a potential horizontal well in the future.

We kindly request that this well would be approved once again by the BLM as a Temporarily Abandoned well in order to leave this well in its current state, for one additional year, so that further evaluation may be conducted pertaining to possible re-completion and/or fracture stimulation in this well.
