Suspect that pressure was a result of the hydraulic stimulation that was being performed on the Nageezi Unit #406H by Encana. Due to the proximity of the lateral and prior to Encana initiating their completion, a packer was run to isolate the wellhead and casing from any abnormal pressure. Currently, the well is flowing the contaminated gas to a flowback tank until the nitrogen levels are pipeline acceptable at which point the well will be returned to production.
