Drilled 12 1/4" hole to 290' on 12/20/05, set 8 jts of 9 5/8", H-40, ST&C, 32.3# casing at 285'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,040' on 12/28/05, set 67 jts of 7", J-55 LT&C, 23# casing at 3,031'. Cemented lead w/550 sx (144 bbls) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (16 bbls) STD, 4/10% Halad 344. Circulated 25 bbls of cement to surface. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 3,469' on 12/30/05. Underreamed hole to 12" from 3,035' to 3,469'. Utilized natural and air assisted surges to remove near wellbore material. On 2/16/06, set 11 jts 5 1/2" 15.5, J-55 liner at 3,461' with liner hanger at 3,003'. Perforated liner with size 0.51" holes, 120° phasing, 4 SPF from 3,061' to 3,374'. Landed 2 3/8" production tubing at 3,446'.
