SURFACE CASING:

Old Casing: 7", 20#, set to 160' in 8-3/4" hole.

New Casing: 8-5/8", 24#, set to 225' in 12-1/4" hole.

NEW CEMENT: 150 sx Type III cmt (or equivalent) w/3% CaCl₂ & 1/4 pps Celloflake (14.5 ppg & 1.41 cuft/sx & 6.67 gal wtr/sx). Continue to mix cmt until a trace of cmt is observed @ the surface. Shut down & drop plug as normal.

PRODUCTION CASING:

Old Casing: 4-1/2", 10.5#, set to 2100' in 6-1/4" hole.

New Casing: 5-1/2", 15.5#, set to 2000' in 7-7/8" hole.

NEW CEMENT: Lead: Pmp +/- 200 sx Prem lite Hi Strength FM + 2% bwoc Potassium Chloride + 0.5%/sx Celloflake + 0.2% bwoc CD-32 + 0.5% bwoc FL-52 + 2% bwoc Phenoseal + 104.9% fresh wtr @ 12.5 ppg, 2.01 cuft/sx & 10.55 gal wtr/sx. Tail: Pmp +/- 100 sx Type III cmt w/0.3% bwoc CD-32, 0.2% bwoc FL-52, 1/4 pps cello, 2% bwoc Phenoseal + 66.6% fresh wtr (14.2 ppg & 1.54 cuft/sx, 7.51 gals wtr/sx).
