It is intended to recomplete the subject well in the Gobernador Pictured Cliffs (pool 77440) and downhole commingle the existing Blanco Mesaverde (pool 72319) with the Pictured Cliffs. The production will be commingled per Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.
