WPX Energy requests authorization to flare the **N ESCAVADA UNIT #313H** if a potential cross flow event may occur as a result of a nearby Frac activity on **N ESCAVADA UNIT #311/312H**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **1/31/18 for 30 days**, given approval. A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.  
**Per Dave M. (BLM) on 1/19/18: WPX can operate on verbal approval for flaring in the event of government shutdown.**
