Hilcorp Energy was investigating the failed 2017 BH test, and on 11/10/17 injectable packing with PTFE and Aramid Fibers (i.e. plastic) was pumped into the Lackey A 2 wellhead between the 9-5/8" Bradenhead and 7" production casing to seal off communication between both strings of pipe.

11/13/17 an unofficial BH test was performed with 0 psig on the BH and 0 psig after the 5 minute shutin and 100 psig on the casing.

Hilcorp is requesting a witnessed BH test to show the resolution of the Lackey A 2 well in regards of meeting Rule 19.15.16.11.
