On 1/28/06, ran 14 jts of 5 1/2", J-55, 15.5#, LT&C Liner was run to 3,314' with 0 sx of cement. Top of liner is at 2,735'. Perforations are from 3,031' - 3,232', 4 SPF, 0.51", 224 holes, 120 degree phasing. On 1/29/06 ran back in hole with 98 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,305', return well to sales on 1/30/06.
