Well was shut-in effective 4/6/06, due to new completion of SJ 28-7 #259G, which is a downhole commingled well producing from the Blanco Mesaverde and Basin Dakota. OCD will not allow both wells to produce from the Dakota at same time due to their being in same acreage. Engineers are discussing idea of plugging back the #259 and producing from the Chacra and Pictured Cliff.
