Maralex Resources is applying for a pipeline right-of-way (sundry attached) to tie the Alexandra Ballard # 1 into an existing Enterprise tie-in in Section 18-25N-11W. The ROW will cross BLM lands (survey is attached).

Upon the receipt of the BLM's approval of the proposed ROW, Maralex Resources intends to acidize and frac the well, lay the proposed pipeline and connect the well to sales. At this time, we respectfully request a one year extension to the Temporary Abandoned status to give us adequate time to receive ROW approval and to complete the work described above.

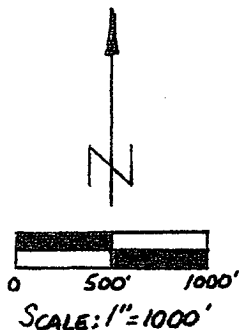

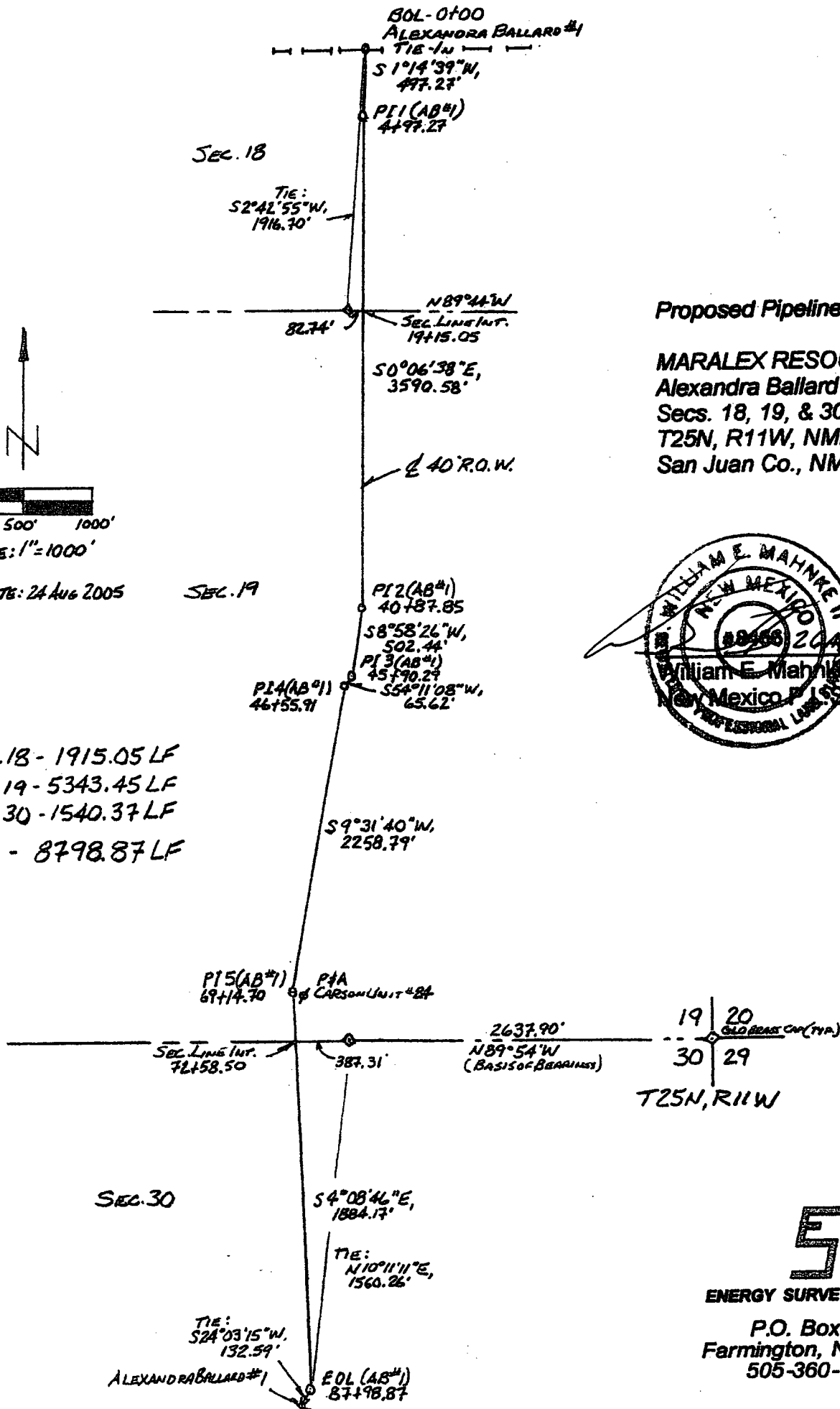
