JOB PROCEDURES

1. MIRU service rig and associated equipment; test BOP.
2. TOOH with 2 3/8" tubing set at 7,641'.
3. Set a 4-1/2" cast iron bridge plug at +/- 5,875' to isolate the **Dakota**. Note: TOC at 2,550' by CBL.
4. Load the hole and pressure test the casing to frac pressure.
5. N/D BOP, N/U frac stack and test frac stack to frac pressure.
6. Perforate and frac the **Mesa Verde** in two or three stages (Top Perforation @ 4,800'; Bottom Perforation @ 5,700').
7. Isolate frac stages with a composite bridge plug.
8. Nipple down frac stack, nipple up BOP and test.
9. TIH with a mill and drill out top isolation plug and **Mesa Verde** frac plugs.
10. Clean out to **Dakota** isolation plug and, when water and sand rates are acceptable, flow test the **Mesa Verde**.
11. Drill out **Dakota** isolation plug and cleanout to PBTD of 7,747'. TOOH.
12. TIH and land production tubing. Get a commingled **Dakota/Mesa Verde** flow rate.
