13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. BP respectfully requests approval to change the route and method of fresh water transportation associated with our Northeast Blanco 604 and 605 well completion activities. Hard poly pipe would be used in lieu of lay-flat hose on certain segments and a portion of the route would be modified to follow existing pipeline ROW instead of roads. We are also requesting approval to leave the poly pipe in place on the surface for up to a 5 year period to facilitate completion activities on additional future pads in the unit. The line will be tested prior to use, monitored during water transfer operations, and drained when it is not in use. The proposed changes along with the new alignment are summarized in the attached maps.

We believe the proposed changes will result in reduced disturbance and costs by eliminating multiple lay-flat hose deployment and removal activities. In addition, the use of poly pipe has additional benefits including reduced pump station requirements and improved durability and reliability. Placement of lines in ROW's instead of along roadsides also reduces the potential for damage due to vehicle traffic or vandalism.
