It is intended to recomplete the subject well in the Blanco Mesaverde (pool 72319) and Basin Mancos (pool 97232) and downhole trimmingle the existing Basin Dakota (pool 71599) with the Mesaverde and Mancos. The production will be commingled per Oil Conservation Division Order Number 12984-B. Allocation and methodology will be provided after the well is completed. Trimmingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.

Proposed perforations are: MV: 4840' - 5800'; MC: 6484' - 6911'; DK: 7495' - 7682'. These perforations are in TMD. **NMOCD**




