
E. This exception is requested for the following reasons: **Flare Extension**

WPX Energy requests authorization to flare the **W Lybrook Unit #704H** if a potential cross flow event may occur as a result of a nearby Frac activity on the **Athena 2308 14L #2H (3004535633) belonging to Logos**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **3/26/18 for 30 days**, given approval.

A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.
