First stage cement was as follows: Lead with 119 sks Halliburton Premium Cement. Tailed in 176 sks of 50/50 POZ cement and circulated 30 bbls good cement to surface. Second Stage: Lead with 452 sks of Halliburton Premium Cement. Tailed with 166 sks of Premium Class G cement and circulated 10 bbls of good cement to surface. DV tool was set at 5288'. Release Rig on 12-20-14.


