4/13/06 MIRU Mote #1. Spud 12-1/4" hole @ 0900 hrs 4/13/06. Drilled to 137'. Circ. hole. RIH w/ 4 jts 9-5/8", 32.3# H-40 casing and set @ 137'. Pumped preflush of 6 bbls FW, then pumped 50 sx (81 cf - 14 bbl slurry) Type I-II Portland cement with 20% Flyash. Dropped plug and displaced w/7.2 bbls FW. Circ. 3 bbls cement to surface. WOC. Installed WH. RD & released Mote @ 1700 hrs 4/13/06. PT will be conducted by the drilling rig and be reported on next test.
