Cement second stage with 250 sks 65/35 Class B poz, 6% gel, 2% CaCl2, 10#/sk gilsonite, 1/4#/sk flocele tailed by 50 sks Class B, 1/4#/sk flocele, 5#/sk gilsonite (552 cu.ft.).
