Cement with 225 sks Class B, 2% CaCl2, 5#/sk gilsonite, 1/4#/sk flocele (266 cu.ft.). Plug down @ 9:00 pm on 04/10/06. Circulate 18 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
