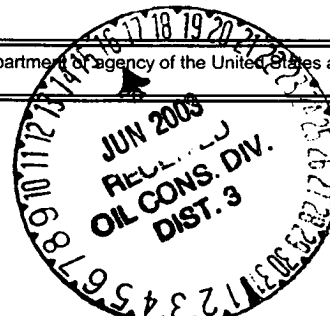

Conditions of Approval: Notice of Intent to Recavitate

- 1) No construction, drilling or workover activities can be conducted between November 1 and March 31 due to Bald Eagle Wintering. All recavitation activities must be confined to the original disturbed area. Refer and adhere to the original permit requirements and the following:
 - a) All workover pits will be fenced during the recavitation operation and fenced closed after the completion of the work.
 - b) Pits must be lined with 12 mil, or greater, reinforced liner.
 - c) All coal fines must be confined to the pit. Any off location spray of coal fines must be immediately washed down with fresh water.
 - d) Pits must be reclaimed within 90 days of the completion of the workover operations.
- 2) Notify the Farmington Filed Office Inspection and Enforcement Division @ (505) 599-8907 within 24 hours prior to commencing well bore recavitation operations.
- 3) Prior to commencing recompletion operations, BOPE must be installed and tested in accordance with the requirements outlined in Onshore Order No. 2.
- 4) Within 30 days of completion of the operations as proposed, file one original and three copies of Sundry Notice (form 3160-5) detailing the work conducted.
