Perforate Fruitland Coal from 682'-702' & 707'-720' w/4 spf (total 33', 132 holes) on 4/18/18. Broke down perms w/800 gals 15% HCl. Fracture treated well w/73,250 gals crosslinked foam and 132,000# 20/40 sand (5/1/18). Ran 2-3/8" 4.7# J-55 tbg, landed @ 754', SN @ 717' (5/9/18).
