Pumped a preflush of 20 bbls FW w/dye in last 10 bbls. Then pumped 135 sx (156.6 cf - 27.9 bbl slurry) Class G cement w/2% CaCl₂, .25#/sx Cellophane. Released wiper plug and displaced w/15.3 bbls FW. Bumped plug w/330 psi. Circ. 13 bbls good cement to surface. WOC. NU WH & BOP. PT plug & casing to 1500 psi for 30 minutes. Good test.
