Encana Oil & Gas (USA) Inc. (Encana) requests concurrence from the BLM that the vegetation standards for interim reclamation on the LYBROOK I10-2308 01H and LYBROOK I10-2308 02H (API 30-045-35510) well pad (wells were not drilled) have been met. The average foliar cover scores for the line transect is 26%. Although this is below the 35% vegetation percent cover standard for the Sagebrush/Grass Vegetation Community, Encana believes that because the transect score is within 10% of the standard and the overall vegetation on the location meets the intent of interim reclamation (short term stability, visual, hydrological and productivity objectives), this location should be considered attained and moved into long-term monitoring.
