6/14/03 RIH w/6-1/4" bit & drilled out cement shoe @ 3796 - 3836'. Drilled ahead to 8168' (TD). TD reached 6/17/03. Circ. hole. RIH w/4-1/2", 11.6#, I-80 casing and set @ 8166'. RU Halliburton to cement. Pumped a preflush of 30 bbls 2% KCL water, then pumped - 515 sx (747 cf - 133 bbl slurry) 50/50 POZ, Class G STD, 3% Gel, 0.2% CFR-3, 0.1% HR-5, 0.8% HALAD-9, 5#/sx pheno-seal. Displaced w/126 bbls 2% KCL. Plug down @ 1625 hrs 6/17/03. No cement to surface. ND BOP, set slips and cut off casing. RD & released rig 6/18/03. Will show casing PT on next report.
