13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. BP suspected the casing collapsed on the tubing in the subject well. The tubing has been cut at 6316'. BP requests approval to abandon the Dakota completion by pumping a cement plug with calculated top of 6200'. This will give us ~64' of rat hole below our deepest Mesaverde perforation. We will tag the plug to confirm the top is at 6200' and will place an additional cement plug if necessary to bring cement to 6200'. After we successfully set the plug(s), BP plans to run tubing to produce the Mesaverde formation.

BP received verbal approval to proceed with the above work 5/31/2018 from the NMOCD and BLM.
