PLUG AND ABANDONMENT PROCEDURE

May 20, 2018

Los Pinos Ft / Sd Pictured Cliffs
1510' FSL & 690' FWL, Section 14, T-31-N, R-7-W
San Juan County, New Mexico / API 30-045-32802

Note: All cement volumes use 100% excess outside pipe and 50' excess inside. The stabilizing wellbore fluid will be 8.3 ppg, sufficient to balance all exposed formation pressures. All cement will be Class G, mixed at 15.8 ppg with a 1.15 cf/sx yield.


1. Install and test location rig anchors. Comply with all NMOCD, BLM, and Operator safety regulations. MOL and RU daylight pulling unit. Conduct safety meeting for all personnel on location. Record casing, tubing and bradenhead pressures. NU relief line and blow down well. Kill well with water as necessary and at least pump tubing capacity of water down the tubing. ND wellhead and NU BOP. Function test BOP.
2. Rods: Yes , No , Unknown .
Tubing: Yes , No , Unknown , Size 2-3/8" , Length 3544' .
Packer: Yes , No , Unknown , Type .
3. **Plug #1 (Pictured Cliffs perforations and top, 3397' – 3282')**: Round trip 4.5" gauge ring to 3397' or as deep as possible. RIH and set 4.5" CR at 3397'. Circulate well clean. Pressure test casing to 800#. If casing does not test then spot or tag subsequent plugs as appropriate. Spot 13 sxs Class G cement inside casing from 2922' to cover the Fruitland top. PUH.
4. **Plug #2 (Fruitland top, 3032' – 2932')**: Mix 12 sxs Class G cement inside casing to cover the Fruitland top. TOH and LD tubing. PUH.
5. **Plug #3 (Kirtland and Ojo Alamo tops, 2549' – 2325')**: Mix 21 sxs Class G cement inside casing to cover the Kirtland and Ojo Alamo tops. TOH and LD tubing. PUH.
6. **Plug #4 Nacimiento & 9 5/8" surface shoe, 325' – Surface)**: Establish circulation out bradenhead with water and circulate the BH annulus clean. Mix approximately 26 sxs cement and pump down the 4.5" casing to circulate good cement out bradenhead. Shut in well and WOC.
7. ND cementing valves and cut off wellhead. Fill annuli with cement as necessary. Install P&A marker to comply with regulations. Record GPS coordinate for P&A marker on tower report. Photograph P&A marker in place. RD, MOL and cut off anchors. Restore location per BLM stipulations

CONDITIONS OF APPROVAL

1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Lease."
2. Farmington Office is to be notified at least 24 hours before the plugging operations commence (505) 564-7750.
3. The following modifications to your plugging program are to be made:
 - a) Set Plug 1 (3397 – 3234) ft. to cover the Pictured Cliffs top. BLM picks top of Pictured Cliffs at 3284 ft.
 - b) Set Plug 2 (3023 – 2923) ft. to cover the Fruitland top. BLM picks top of Fruitland at 2973 ft.
 - c) Set Plug 3 (2524 – 2292) ft. to cover the Kirtland and Ojo Alamo tops. BLM picks top of Kirtland at 2474 ft. BLM picks top of Ojo Alamo at 2342 ft.
 - d) Add a cement plug (842 – 742) ft. to cover the Nacimiento top. BLM picks Nacimiento at 792 ft.

You are also required to place cement excesses per 4.2 and 4.4 of the attached General Requirements.
