MIRU drilling unit @ 9:00 on 8/27/18 & spud a 8-3/4" surface hole. Drilled to 240'. RU and ran 7" 20# K-55 CSG to 223'. Cement w/ 111 sx Class G cement @ 15.8 ppg; Yield 1.150 cu-ft/sx. Displaced 10.7 bbls water circ. Circulated 12 bbls of cement to surface. Dropped plug and bumped plug at 255 psi. shut-in pressure was approximately 255 psi. WOC 12 hours. N/U BOP @ manifold/test all valves to 600 psi against surface casing. All valves ok. Received variance from BLM to test against casing to 600 psi.

Drill out CMT. Drilled a 6-3/4" hole to 741'. RU and run 4-1/2" casing, 11.6# P-110 to 734'. CMT 4-1/2" csg w/ 120 sx Class G cement @ 15.8 ppg; Yield 1.15 cu-ft/sx. Displaced 9.5 bbls of water. Circulated 10 bbls of cement to surface. Dropped plug and bumped plug at 1155 psi. Last pressure and rate observed was 475 psi @ 2.3 bbls/min.
