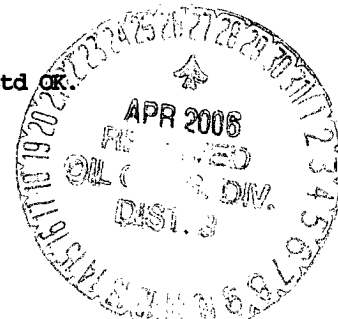

Cmt'd 1st stage w/200 sx Prem Lite HS cmt w/2% CaCl2, 1/2 pps celloflake, 0.2% CD32, 0.5% FL52, & 2% phenoseal (12.5 ppg & 2.01 cuft/sx) followed by 200 sx Type III cmt w/0.3% CD32, 0.2% FL52, 1/4 pps celloflake, & 2% phenoseal (14.2 ppg & 1.54 cuft/sx). Drpd bomb & open DV tl. Circ 30 bbls cmt. Cmt'd 2nd stage w/350 sx Type III cmt w/8% bentonite, 1/4 pps celloflake, & 2% phenoseal (11.9 ppg & 2.6 cuft/sx) followed by 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Drpd bomb & closed DV tl. Circ 45 bbls cmt to surf.

PT csg to 1,500 psig for 30 min w/chart. Incrd press to 3,850 psig for 5 min. Tstd OK.
